



**GRUPO ELEKTRA ANNOUNCES
THE SUCCESSFUL COMPLETION OF THE ISSUANCE OF SENIOR SECURED NOTES
BY ITS SUBSIDIARY NUEVA ELEKTRA DEL MILENIO, S.A. DE C.V.**

For the benefit of the investors, the information disclosed below is not related to the trade suspension of our shares ordered by the Mexican Stock Exchange.

Mexico City, October 29, 2024—Grupo Elektra, S.A.B. de C.V. (the “Company”) (BMV: ELEKTRA*; Latibex: XEKT), Latin America’s leading specialty retailer and financial services company, and the largest non-bank provider of cash advance services in the United States, today announced that its subsidiary, Nueva Elektra del Milenio, S.A. de C.V. (“**NEM**”), as originator, successfully completed the indirect issuance of new Senior Secured Notes under its remittances future flow financing program through a private offering of securities made abroad in accordance with Rule 144A and Regulation S of the Securities Act of the United States of America of 1933 (as amended, the “**United States Securities Act**”) in the principal amount of USD\$350 million with a 12.500% rate due 2031 (the “**Senior Secured Notes**”). The Senior Secured Notes shall have a corporate guarantee by which the Company unconditionally and irrevocably guarantees to pay the Default Payment and Additional Amounts payable by NEM.

The Senior Secured Notes were rated “BB+” by S&P, “Ba3” by Moody's and “BBB” by HR Ratings. The Company intends to use the net proceeds of the offering to redeem in full the Series 2021-1 senior notes, fund the Series 2024-1 Reserve Account and make an Additional Payment to NEM.

The Senior Secured Notes have been filed to be listed on the Luxembourg Stock Exchange – Securities Official List, without admission to trading.

The Senior Secured Notes have not been, and will not be, registered in the National Securities Registry (“*Registro Nacional de Valores*”) maintained by the National Banking and Securities Commission (“*Comisión Nacional Bancaria y de Valores*” or “*CNBV*”) and will not be and cannot be offered or sold in Mexico without the authorization of the CNBV unless offered or sold to institutional investors or qualified investors pursuant to private offer

exceptions set forth in article 8th of the Securities Market Law (“*Ley del Mercado de Valores*”) and other applicable provisions.

This press release does not constitute an offer to sell, or the solicitation of an offer to buy, any securities of the Company, NEM or Mexico Remittances Funding Fiduciary Estate (the “**Issuer**”), nor will there be any sales of securities of the Company, NEM or the Issuer in the United States of America or any other jurisdiction in which, or to any person to whom, the offer, solicitation or sale would be unlawful.
